These areas could be Countries, Territories, Emerging Economies or specific geographic areas. They do not have to pay entrance fees or membership subscriptions for 3 years. They do not have the right to vote at any meetings or stand for elections or make a bid for any AFAA promoted events. <p>Upon reaching 3 years as an Affiliate Member, the Member must apply for upgrading their Membership to that of a Regular Member.</p>	<ul style="list-style-type: none"> A person who is recognized for his/her contribution to AFAA and the marketing communications industry. The Executive Committee will propose such names and this will require the approval of the General Body. All Honorary Life Members may attend all meetings of the General Body without voting rights.
